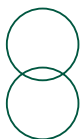

INGREDIENTS: Resistant Potato and Tapioca Starch, Acid (E330), Himalayan Mountain Salt (Sodium Chloride), Oolong Tea Leaves with Cider Vinegar (*Camellia sinensis* L.), Blueberry Juice Powder (*Vaccinium corymbosum*), Cranberry Juice Powder (*Vaccinium macrocarpon* L.), Stabiliser (E415, E412), Grape Seed Extract (*Vitis vinifera* L.), Medium Chain Triglycerides from Coconut Oil (*Cocos nucifera*), Citrus Flavour, Sweetener (E960a), Vitamin C (Ascorbic Acid), Zinc (Zinc Gluconate), Riboflavin

Mode of Use:

Mix the daily dose of 18,0 g (2 scoops of powder) in 240 ml of water. The daily dose can be split into 2 doses of 9 g (1 scoop) mixed with 120 ml of water taken twice a day.
